

### SHARE OF AFT IN DEVELOPMENT FINANCE AND FIXED CAPITAL FORMATION (%)





### LOGISTICS PERFORMANCE INDICES (LPI) (1-5)




## **TRADE FACILITATION INDICATORS, 2017 (0-2)**


